Keisler made a few phone calls, a team of subject matter experts was formed and thanks to the hard work of such generous partners, this innovative service for our business community is being launched. Keisler stated "This is just another demonstration of Catawba County's "secret sauce" in action ---collaboration and partnerships."

In addition to easing this pain point for our local business community, it also expands our capacity for COVID-19 testing in Catawba County overall. "We are excited to see another testing option coming to our county. Testing is an important tool in the COVID-19 toolbox and helps people make decisions that will help protect their families, friends, coworkers and our community's most vulnerable residents," said Jennifer McCracken, Catawba County Public Health Director. "However, no matter if or when a person is tested, we must all remain diligent in taking protective actions – maintaining 6 feet of social distancing whenever possible, using cloth face coverings or masks, and practicing frequent handwashing. By protecting ourselves and our loved ones, we are also protecting our workforce, which is an important part of keeping Catawba County's economy strong."
