## TALENT@WORK

- Convened leaders in hospitality, the CVB and CVCC to discuss talent needs for both now and in the future. As a result, this group worked to create the CVCC Hospitality Academy that launched in July. It is a 12-week program, and in addition to learning many different skills, CVCC students can earn three certifications — Servsafe, TIPS (Training for Intervention Procedures), and RASP (Responsible Alcohol Seller/Server Program). The first cohort graduated in November.
- Hosted a regular convening of our partners in Workforce Development we call the **Workforce Masterminds Huddle** (*K-12, K-64, CVCC, LRU, NCCET, EDC, NCWorks, WPCOG, Chamber*) to provide a platform to share regular updates on new and ongoing programs and initiatives aimed at filling jobs across our region.
- Hosted **Workforce Solutions Industry Roundtables** with Maiden area employers (October) & Newton (November) area employers to discuss needs and solutions around talent recruitment, retention & development. Invited workforce partners to connect them directly to fill their needs (*K-64/CVCC; EDC, WPWDB/ NCWorks; Chamber*). Plan to host one in each of the other 6 municipalities over the next several months.
- Met weekly with Shareholders & Investors and their leadership teams to help **audit and refine their talent recruitment and retention strategies** to ensure they are optimizing their use of local resources. Often we pull together other resource partners to join us to make direct connections and glean from their areas of expertise.

- Hosted the **Diversity, Equity & Inclusion Summit** on May 19th – We secured thought leaders from both our local business community and across the country to share their insights, lessons learned and best practices about diversity and inclusion in the workplace. 265 attendees attended virtually.
- Continue to lead **"The Catalyst: Entrepreneurs Supporting Entrepreneurs,"** a collaborative of local founders, mentors and entrepreneurial support representatives (Chamber, SBTDC, the CVCC Small Business Center, the Manufacturing Solutions Center, SCORE and Lenoir Rhyne University) who are growing Catawba County's start-up community.

- Managed the Land Use Development Board, a partnership with the CV Realtors Association and the CV Homebuilders Association to discuss and review land use policies in Catawba County to ensure we maintain a business-friendly landscape for residential and commercial development.
- Utilized the **EssCert** platform to issue & certify 504 exporting documents for our Shareholders & Investors, year to date.
- Legislative Agenda Taskforce drafted and proposed our 2021 Legislative Agenda, which was adopted by our Board of Directors on February 17th. These local business priorities have been communicated with our local, state and federal elected officials.

- Hosted 2 webinars regarding the **Biden Administration** Vaccine/Testing Mandate for employers with 100+ employees (September & November) to assist them with dissecting the mandate & making preparations in the event that it was upheld.
- Co-hosted a **Regional Housing Forum** on Friday, August 27th in partnership with the Western Piedmont Council of Govts to discuss the state of housing in the Hickory-Lenoir-Morganton MSA. 100 were in attendance.
- On Wednesday, December 15th, hosted a **Legislative Update with Speaker of the NC House of Representatives Tim Moore**.
